## 1902 Proposal for a community garden by Cllr C Evans

Cllr Evans gave an overview of the proposed Fortune's Community Garden project. It was felt that by being located in close proximity to the town centre, the garden would support town regeneration and the Cleddau Reaches project. A number of organisations are already in support of the proposal, including Pembrokeshire County Council, Plantlife, Hywel Dda Health Board, Pembrokeshire Coast National Park.

## Cllr C Thomas returned to the meeting at 6.53pm

Grant applications would be made under the Local Places for Nature Fund and Coastal Communities Fund to support the lease of land, creation and management of the garden, two employment posts – Town Gardener and Community Engagement Officer. The funding would run until 2023 at which point it is hoped the project will be self-sustaining.
