Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000	<p>Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.</p> <p>In 2023-24, the Council made payments totalling £18,273 under section 137. These payments are included within 'Other payments' in the Accounting Statement.</p>
2.	<p>The Council experienced a sudden change in administration in the second half of the financial year. The new Clerk/RFO joined on 1 November 2023. The period from this point has involved a period for review, familiarisation and consolidation of Council processes against best practice with a key focus on improvement and removing systemic inefficiencies so that, going forward, the Council and Administration has a better platform on which to operate. This has involved a review of existing resources, in terms of both systems and people, and has resulted in decisions to replace the existing website and accounting software, together with modular tools to better support the management of cemeteries, and bookings, in the first half of 2024-25, thereby freeing up the time of Clerk and other Officers to support Council and, ultimately the town people, on a more strategic level. While some good progress has been made in the period under review, there is more to do in the current financial year ahead of the full audit in 2024-25.</p>


